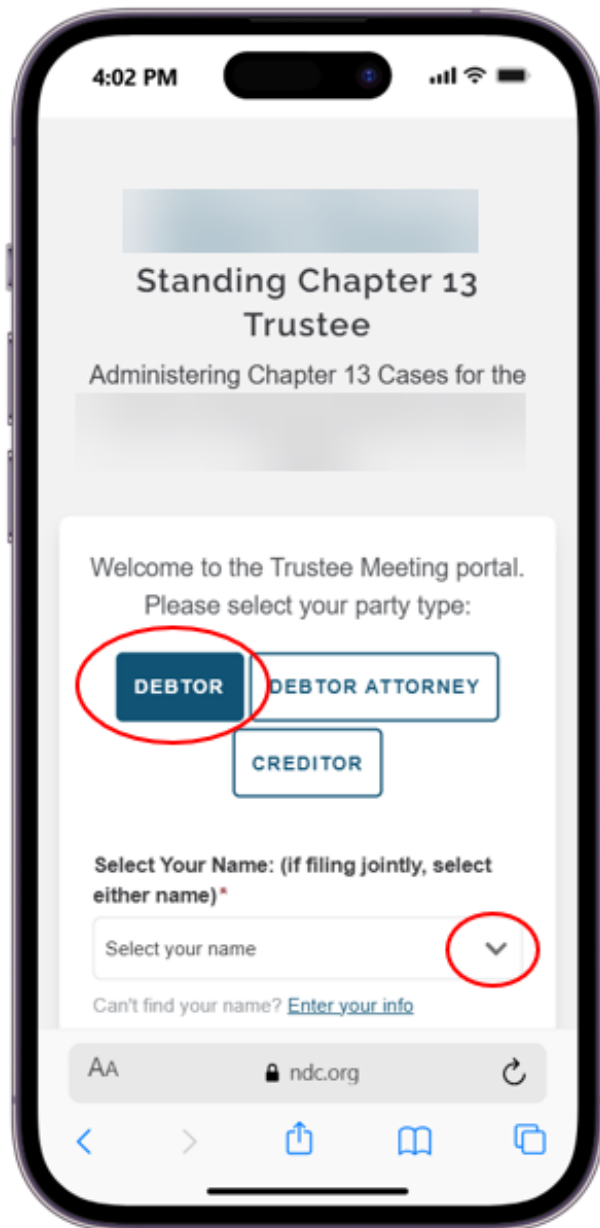


INSTRUCTIONS FOR DEBTORS TO CONNECT TO THE TRUSTEE'S 341 ZOOM PORTAL

The Trustee's 341 Zoom Portal is a simplified way to connect to your Zoom 341 Meeting. Follow the instructions, below, to connect.

1. Open your web browser on your computer or smartphone and go to the Trustee's NDC zoom portal.

2. Make sure that the party type of **DEBTOR** is highlighted, then click the down arrow in the box next to the words 'Select Your Name'



3. Choose your name from the drop-down list. This will fill in your information. **If your name is not on the list, go to step 5.**

FBI INVESTIGATES BANKRUPTCY CRIMES

Federal law provides severe criminal penalties for bankruptcy crimes, which include bribery, concealment of assets, false statements, false claims, filing under a fictitious name and perjury. Title 18, United States Code, Section 152 and 3571, provide penalties of up to 5 years imprisonment or a fine of not more than \$250,000, or both.

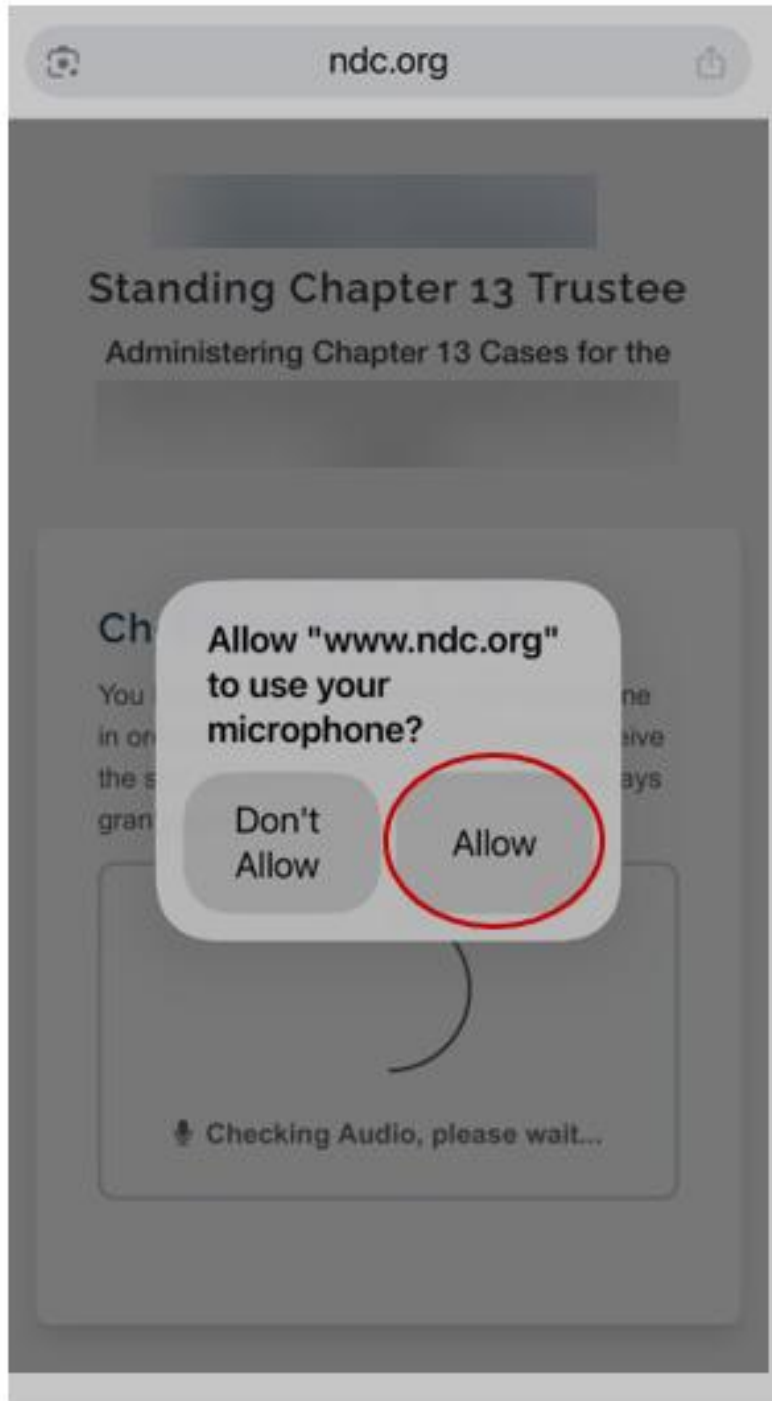
LA FBI INVESTIGA DELITOS DE BANCARROTA

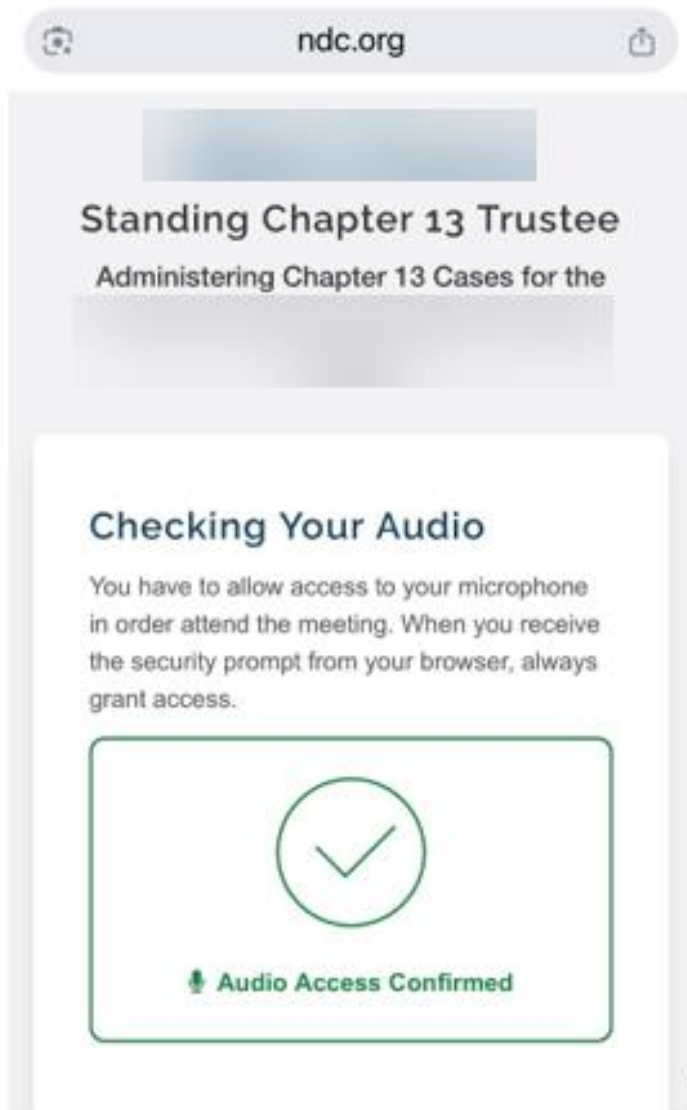
La ley federal establece severas sanciones penales para delitos de bancarrota, tales como el soborno, el encubrimiento de activos, declaraciones falsas, demandas falsas, declaraciones bajo nombres ficticios y perjurio. Los artículos 152 y 3571 del Título 18 del Código de los Estados Unidos establecen penas de hasta 5 años de prisión, multas no mayores a 250.000 dólares, o ambas.

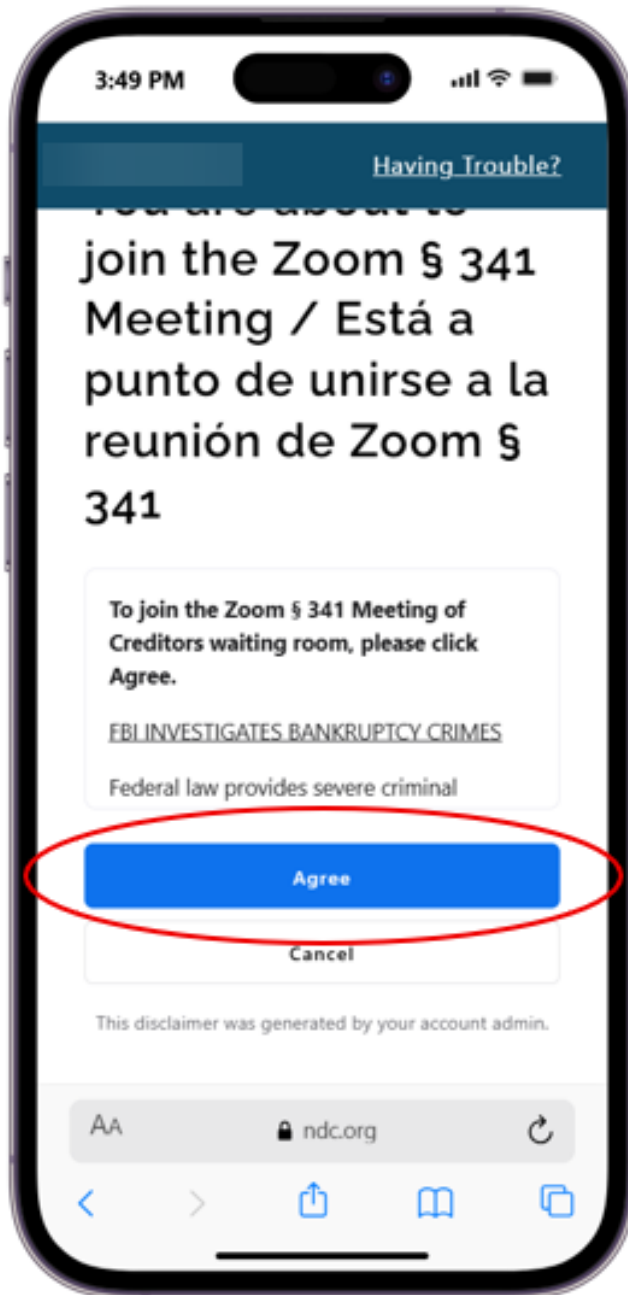
You have to allow access to your camera in order attend the meeting. When you receive the security prompt from your browser, always grant access.
